## **14. Any Other Business** (as agreed at the beginning of the meeting)

Katie Lane spoke about possible reorganisation of the Guild. She said that in recent years this has been discussed, although Covid has slowed this process. At the March General Committee meeting John Harrison had prompted the officers to bring forward proposals shortly. Since then the principal officers have met to talk further. These are the main issues that we consider most important:

The present structure and roles predate the ways in which organisations should work with modern technology. The present structure is clearly of little interest to many existing members. There are concerns about meeting the quorum requirements at AGMs and there are vacancies in our list of officers. A revised meeting structure could make better use of our time and be more productive. Guild functions should be attractive events to encourage

more members to attend. There are increasing difficulties in finding volunteers to take on the roles. The advantages and disadvantages of making the Guild a charity should be discussed.

We propose to finish a strategy paper with the help of some other contributions. A consultation paper will be circulated among a range of members this summer for feedback. Detailed proposals will be prepared for the November General Committee meeting with a view to the first steps being undertaken after the 2023 AGM. This is a tight schedule, but the Master said that she would rather that we went for it even if we subsequently need more time.

Tim Pett raised the issue of the number of members to be consulted during the process. John Harrison thought that before the final proposal went out to all members there should be a process of consultation in various groups to ensure that some aspects were not misunderstood. The CRAG process in the Central Council went through several layers. It is preferable to put the proposals through various collaborating members who will point out its faults before it goes out to all members.

The meeting was shown the mascot of the ODG Young Ringers and the trophy won by them last year. They were wished good luck for this year's contest at Exeter.

The Master closed the meeting.
